## **Protecting Your Privacy**

#### **Your Personal Information**

Personal information held by Simply Uniforms may include your name, gender, current address, telephone/mobile phone number and e-mail address. We also hold details of any previous or ongoing service provision. Your information is held in strict confidence.

If you choose not to provide personal information we may not be able to provide you with the level of service we aspire to.

## **How We Collect Personal Information**

Simply Uniforms collects personal information through voluntary provision of such by the customer. This may be verbally given, in written form or transmitted electronically.

## **How We Use Your Personal Information**

Your personal information may be used to:

- Control and improve quality through customer feedback.

#### When We Disclose Your Personal Information

No personal customer information is disclosed to any party external to the Simply Uniforms organisation. If we wish to use any of this personal information, business information or data for any purpose other than that specified above, we would not do so unless we have your express consent to do so. Exceptions to this include:

- where there are reasonable grounds to believe that disclosure is necessary to prevent a threat to life or health; or
- where disclosure is required by law or is reasonably necessary to assist a law enforcement agency.

We will take reasonable steps to ensure that all information we collect, use or disclose is accurate, complete, up-to-date and stored in a secure environment accessed only by authorised persons.
